

MEMORANDUM
on Ownership Structure
(2025)

This memorandum has been prepared to inform investors about the ownership structure of the GTI Group of Companies. To provide a clear understanding of this structure, the document includes information on the companies that are part of the UST Group of Companies and, consequently, owned by the investors, as well as details about independent marketing firms that perform intermediary and representative functions.

The GTI Group of Companies was established to develop uST transport and infrastructure complexes (freight and urban cargo-passenger), facilitate their practical implementation (manufacturing and construction), demonstrate their capabilities, certify them, and oversee the subsequent operation. The group of companies features a branching structure, encompassing a holding company and various subsidiaries.

Thus, the GTI Group of Companies is both the developer and owner of the uST technology, which includes intellectual property, know-how, patents, and various design, engineering, and research documentation. The group also holds assets, including both intangible and tangible assets, land, buildings, and other structures.

The GTI Group of Companies is not a separate legal entity, corporation, association, or similar formation. Rather, it represents a structure of interrelated legal entities focused on the implementation of the uST transport and infrastructure technology.

The GTI Group of Companies includes the holding company **Global Transport Investments Inc. (GTI)** and several subsidiaries. **GTI** owns manufacturing and engineering companies, as well as utility companies established (acquired) to serve as asset owners, particularly in real estate, including office and manufacturing facilities, structures, and more.
